County, State of Nevada, for the following reasons and on the following grounds, to wit:

Dry Lake Water Company LLC owns water rights with points of diversion within Black Mountain Basin #215, and is advancing pending appropriation applications in Basin 210, 215, 216, 217, and 218. Diversions under Applications 65944-65949 and 65954-65955, combined with existing and pending appropriations, would exceed the perennial yield of Basin 218. As there is no unappropriated water at the source after accounting for existing permits and pending applications to appropriate, this Application threatens to prove detrimental to the public interest. The Application further conflicts with existing rights and applications in Basin 218 and surrounding basins. Finally, the Application does not satisfy NRS 533.360 or 533.370. Because the Las Vegas Division of Water Resources' files are not complete and up to date, Protestant reserves the right to amend and supplement this protest as necessary.

THEREFORE the protestant requests that the application be denied

(Denied, issued subject to prior rights, etc., as the case may be)

and that an order be entered for such relief as the State Engineer deems just and proper.


