We wish to protest the water rights applications #67319 through #67333 (15 applications). These applications seek to use 46,040 acre-feet per year of water. This water withdrawal would be above and beyond the 18,835 acre-feet per year already permitted and certificated in Spring Valley. It is our understanding that 181,641 acre-feet per year of water rights in the Spring Valley area are "ready for action". In addition, Las Vegas Valley Water District has 19 water rights applications pending for potentially 50,000 acre-feet per year in this same area.

It is our understanding that the proposed water withdrawals will dry up and drastically alter the vegetation of Spring Valley. They will most likely kill the remnant "cedar" or juniper forest on federal lands. They will diminish the ability of private ranchers to make a living from their ranch properties. They will diminish the ability of wildlife to survive in Spring Valley. They will affect the recreational enjoyment of visitors who travel Highway 50 and 6 through Spring Valley and visit Great Basin National Park, which was established to represent the Great Basin.

The history of the Great Basin includes many examples of the deleterious and irreversible effects of water withdrawals on natural Great Basin ecosystems. Spring Valley remains one of the examples of a lush valley that supports ranching and recreation, along with native wildlife and vegetation. We sincerely hope that Spring Valley will be allowed to remain in this state for the indefinite future.
