County, State of Nevada, for the following reasons and on the following grounds, to wit:

Massive groundwater withdrawal in this area (this application is one of many) will have a negative impact on native wetlands, upland springs and quite likely the Shoshone Ponds with their populations of endangered relic fish. The Swamp Cedar Natural Area and its relic population of Rocky Mountain juniper (*Juniperus scopulorum*) may also be affected.

Wetlands are our most biologically diverse and productive lands and national policy is to prevent any net loss. Hence, groundwater diversions which would eventually dewater these areas are completely inappropriate.

THEREFORE the protestant requests that the application be DENIED  
(Denied, issued subject to prior rights, etc., as the case may be)

and that an order be entered for such relief as the State Engineer deems just and proper.
