

Protest rationale filed by
Friends of Nevada Wilderness
August 10, 2001

Application Number 67330
Vidler Water Company, application filed on June 6, 2001

Friends of Nevada Wilderness, protests the filing for appropriation of additional waters in Spring Valley by Vidler Water Company for the following reasons:

The utilization of additional waters by Vidler, for agriculture or other uses could result in the reduction of the water table in Spring Valley and reduce the flow of surface springs and waters in the Schell Creek Range as well as in the valley. Both the Schell Creek Range and Spring Valley are important sites for numerous wildlife who depend on the water resources in the area. Spring Valley contains numerous wetlands that provide critical wildlife habitat. A reduction of these wetlands would be a violation of Federal Policy requiring no net loss of wetlands.

Special values occurring in Spring Valley may also be affected. The BLM manages a special area, The Swamp Cedar Instant Study Area in Spring Valley. This special area consists of a small remnant stand of swamp cedars (Rocky Mountain Junipers) that still cling to this site of its historic habitat because the water table is still adequate to maintain their existence.

Friends of Nevada also recognizes the potential economic impacts to existing ranchers in the valley should their water supply be adversely impacted due to the proposed additional water withdrawals by Vidler.

Spring Valley is in a delicate ecologic balance and should this be disrupted, by Vidler's additional water use, wildlife, ranchers and other special values would be compromised. The application by Vidler Water Company should be denied.
