EXHIBIT A

Applications 68807 through 68811, as applied for, are located on public lands managed by the Bureau of Land Management, Winnemucca Field Office (WFO). The applicant, High Rock Holdings, LLC does not presently have authorization to conduct surface disturbing activities at these locations, nor have they sought approval for a right of way to convey water to another location where beneficial use could be proven. Once the applicant has submitted an application for right of way, to this office, an environmental analysis will be conducted to consider whether or not these activities will cause any significant environmental impacts. Therefore, the Bureau of Land Management protests the granting of these applications until such time that a right of way application can be submitted and considered by this office.
