

**Applications 69071 through 69078**

The above referenced applications are for 5.0 cfs each of underground water from the Smoke Creek Desert Hydrographic Basin (# 21). The annual duty associated with these applications is unknown. The manner of use is described as Irrigation of approximately 1600 acres of land .

On March 27, 1998 Washoe County filed Applications 63992 through 64004 for all the unappropriated ground water within this basin. Furthermore, there have been several other applications filed after this date to appropriate underground water from this basin.

It is clear that there are many applications pending determination by the State Engineer. If the State Engineer grants Washoe County's Applications, then all remaining pending applications, including 69071 through 69078, would have to be denied since there would be no unappropriated water remaining in source. The purpose of this protest is to give Washoe County standing in any hearings regarding applications 69071 through 69078, even if Washoe County's pending applications 63992 through 64004 may have been denied. Washoe County seeks this standing in order to intervene in such a hearing because Washoe County Development Code prohibits long-term mining of ground water resources anywhere within Washoe County. Therefore, Washoe County request the State Engineer to limit total appropriations from this basin to the currently published perennial yield of 16,000.00 acre-feet determined by the United States Geologic Survey (USGS). This limitation would prevent any potential ground water mining within this basin until Washoe County concludes its basin resource analysis for the Smoke Creek Desert. Furthermore, we seek standing because in the recent years new methods and new basin resource studies have resulted in large increases in the perennial yield estimates throughout the State of Nevada. If such a study is utilized in support of these applications that has resulted in an increase in the perennial yield estimates for this basin, then Washoe County feels strongly about having the opportunity to evaluate and question the study during the course of an administrative hearing.
