

As is fairly clearly demonstrated in the report "Potentiometric Surface, Carbonate-Rock Province, Southern Nevada and Southeastern California, 1998-2000" (prepared by the U.S. Geological Survey in cooperation with the Nevada Division of Water Resources) and associated maps and charts, the measured altitude of ground water – the level to which water will rise in a well – is considerably higher in the area for which application has been made than it is in the farmland of Amargosa Valley.

Our family has been farming alfalfa in Amargosa Valley for more than a decade, feeding dairy animals that provide milk for Las Vegas, feeding horses all over Nye County and into California, and providing feed also for the mule trains at Furnace Creek in Death Valley National Monument. We are proud American farmers.

If these permits are granted, our water supply will be directly threatened.

Study after study has shown that not enough water will come into the aquifer each year to recharge the water drawn off by the uses that have been applied for.

If the water level in the aquifer drops, we – and countless other farmers in the region – will be faced with stark choices: To spend tens of thousands of dollars drilling deeper wells, raising the cost of electricity used to pump water to the surface and thereby raising the cost of milk and dairy goods in Nevada, or sitting and watching in horror as our farms turn to dust.

We strongly urge that the application be denied.
