

County, State of Nevada, for the following reasons and on the following grounds, to wit:

The Nye County Board of County Commissioners protests Application #71178, and associated applications (#71174 through #71180, inclusive), and requests that the Nevada State Engineer deny this and the associated applications without further consideration or hearing.

According to information contained in the files of the Nevada Division of Water Resources, there is no groundwater available for appropriation in Basin 230. Existing certificated and permitted water rights exceed the currently accepted perennial yield of the basin and the County has, in recent years, been required to purchase water rights to support County needs and requirements.

The application, if granted, may impair Nye County's senior water rights in Basin 230, as well as the senior rights held by the citizens of the County. The subject application and associated applications total almost 12 cfs or more than 8,600 acre feet. If permitted, the development of this quantity of groundwater from seven closely spaced points of diversion could result in accelerated water level declines, degradation of water quality, increased pumping and water treatment costs, and other impairment.

Nye County has senior water right applications located in Basin 230 (Applications #s 66072, 66077, 66078, 66079, and 66081). The County's applications were timely protested by a number of federal agencies and are now Ready for Protest. If any or all of the County's applications to appropriate groundwater are granted, those water rights could be impaired if the subject application is approved and additional groundwater is developed.

THEREFORE the Protestant requests that the application beDENIED.....
Denied, issued subject to prior rights, etc., as the case may be

and that an order be entered for such relief as the State Engineer deems just and proper.


