





EXHIBIT "A"

Application's 72441, 72449, 72451, 72452 & 72453

The above referenced applications propose to appropriate groundwater from Lemmon Valley East and West Hydrographic Basins. USGS Reconnaissance Report #43 and subsequent studies have estimated the total combined perennial yield of these basins to be 1,500 acre-feet. Preliminary data from the State Engineer's Office indicates existing appropriations of approximately 3,300 acre-feet annually.

Furthermore, there are in excess of 2,000 individual domestic wells located within these basins, which are in addition to the existing appropriations of water rights in these basins.

Additionally, the State Engineer issued a Notice of Moratorium, Order #388, dated May 18, 1971 against issuance of anymore groundwater appropriations in the East Lemmon Valley Basin.

Therefore, Washoe County requests denial of these applications in accordance with NRS 533.370-4 based on:

- 1) There is no un-appropriated water in the source,
- 2) Granting of the applications would conflict with existing rights,
- 3) and could pose detrimental to public interest
