


Aqua Trac, LLC has cumulatively filed numerous water right applications in this same vicinity for a large volume of water. The Bureau of Land Management is concerned that these applications are speculative in nature, and if granted, could result in significant impacts to public land resources. These impacts could include: (1) loss of scarce surface water resources (including Public Water Reserves), (2) loss or degradation of previously granted appropriative rights held by the Bureau of Land Management, and (3) degradation of wildlife and wild horse habitat.

In addition, the point of diversion specified in this application is located on, or is adjacent to, public land. If a permit were granted Aqua Trac, LLC would be required to apply for and be granted a right-of-way to place transmission lines, wells, or other infrastructure on public lands. To date the applicant has not received authorization from the Bureau of Land Management to conduct these activities on public land.

THEREFORE the Protestant requests that the application be Denied, pending further information and action.....  
Denied, issued subject to prior rights, etc., as the case may be

and that an order be entered for such relief as the State Engineer deems just and proper.




