

Application Numbers 72589 through 72602 were filed on April 13, 2005 for municipal and domestic use. The protestant, Lincoln County Water District, recently acquired ownership of two senior municipal applications in Lake Valley (Application Numbers 53993 and 53996). The granting of these applications would unduly impair the protestant's senior applications. The protestant requests that the subject applications be denied.

Because the point of diversion of Application Numbers 72589 through 72602 are within Lake Valley Hydrographic Basin (183) and the place of use is with Coyote Springs Hydrographic Basin (210), the nature of the water use will entail an interbasin transfer. Subsection five of NRS 533.370 requires that certain criteria be met to justify the transfer of water from one basin to another. In this instance, the applicant does not show on face that the requirements of NRS 533.370 (5) have been satisfied.

THEREFORE the Protestant requests that the application be .....Denied.....  
Denied, issued subject to prior rights, etc., as the case may be  
and that an order be entered for such relief as the State Engineer deems just and proper.


