



### ATTACHMENT FOR PROTEST OF APPLICATION 72945

1. The carbonate wells are located in remote areas, so pipelines and related infrastructure would need to be constructed across public lands administered by the BLM to transport water to unspecified points of use at great distance from the specified points of diversion. The applicant also has not been granted or made application for Rights of Ways needed to construct and maintain such pipelines across public lands in these areas.
2. The applications indicate water will be used for municipal and domestic purposes, but there are no municipalities or communities of significant population in the vicinity of the specified points of diversion. It is highly unlikely that the relatively large cumulative total volume of water requested under these applications could be put to the stated beneficial use within a reasonable amount of time as required under State of Nevada water law because of the small population base in the vicinity of the specified points of diversion and adjacent areas.
3. Groundwater discharged from the aquifer systems sustains local riparian and aquatic habitats at springs and seeps on public lands. These habitats support large numbers of diverse plant and animal species and are popular recreational areas for many Nevadans and visitors. Pumping of large volumes of ground water as proposed under the subject applications will drawdown water tables, remove water from aquifer storage, and capture natural discharge that occurs at springs and seeps. Reduced groundwater discharge at springs and seeps will degrade riparian and aquatic habitats in these areas and impair BLM's ability to manage natural resources on public lands as mandated under the Federal Public Lands Management Act.
