Applications 73284, 73285, 73306 & 73307

The above referenced applications request to appropriate a duty of 6625 acre-feet of underground water from the Pyramid Lake Basin. Preliminary data from the State Engineer's office indicates a very limited amount of existing appropriations within this basin. However, it is Washoe County's understanding that the Pyramid Lake Tribe, as a sovereign nation does not follow the State of Nevada's appropriation process. Therefore, the total quantity of existing appropriations is unknown.

Nevada Revised Statutes prohibits the State Engineer to grant a permit to appropriate if there is no water remaining in the proposed source of supply. Therefore, unless a complete inventory of existing appropriations is compiled to determine the availability this application should be denied.
