of Application Number 773326, filed on 10/11/2005
BY LINCOLN COUNTY WATER DISTRICT AND VIDLER WATER COMPANY to appropriate the waters of SAND
SPRINGS VALLEY (AKA: PENOYER VALLEY), BASIN #170, UNDERGROUND situated in SEC. 11,T. 1S. R.56E LINCOLN
COUNTY State of Nevada, for the following reasons and on the following grounds, to wit:

AS HOLDERS OF LIVESTOCK WATER WELLS, IRRIGATION WELL RIGHTS AND SPRINGS RIGHTS IN THIS VALLEY
AND IN CLOSE PROXIMITY TO THE APPLICATION, WE BELIEVE THE GRANTING OF THIS APPLICATION WILL
DAMAGE OUR WELLS, SPRINGS AND RIGHTS OF IRRIGATION WELLS IN THIS VALLEY. THE PREVIOUSLY
APPROPRIATED RIGHTS ALREADY HAVE A DECLINING WATER TABLE. THE BASIN HAS PREVIOUSLY GRANTED
RIGHTS THAT WILL BE IMPERILED IF THIS APPLICATION IS GRANTED, THEREFORE the Protestant requests that the
application be DENIED and that an order be entered for such relief as the State Engineer deems just and proper.
