

Protest Grounds Applications Nos. 73329 and 73330

1. Upon information and belief the Applicant has not secured the necessary right-of-way to beneficially utilize the right sought to be changed and does not have the financial capability to beneficially utilize the subject right.
2. The subject application is an extension of a ploy to tie up all the unappropriated, underground water located in Lincoln County in an attempt to speculate on future development and use, which is not in the public interest. This application is an extension of the foregoing scheme.
3. This application and the proposed use conflicts with existing rights.
4. The subject application is inconsistent with the Bureau of Land Management's Ely Resource Management Plan and is therefore not in the public interest.
