



Applications 73226 through 73231 and 73385 through 73388

The above referenced applications request to appropriate 3.0 cfs and 5.0 cfs respectively with a total combined duty of 13,000 acre-feet from Winnemucca Lake Valley (Basin 80). The proposed place of use of these applications is basins 76 & 83, a portion being within Washoe County.

USGS Open File Report 76-768 estimates the perennial yield of this basin at 3,300 acre-feet. Preliminary data from the State Engineer's Office records indicate existing appropriations of 305 acre-feet. Pending applications 71452 and 71453 also attempt to appropriate 4,000 acre-feet of water from this basin.

Furthermore the applicant has previously filed applications 72463 through 72476, 72479 and 72480 in this basin.

Therefore, based on the foregoing:

- 1) There is no un-appropriated water in the source,
- 2) Granting of the applications would conflict with existing rights,
- 3) and could prove detrimental to public interest
