
Comes now Robert L. and Cathy Valenta Weise and Bobcat Ranch, LLC

APPLICATION(S), KOBEH VALLEY, NEVADA

BOBCAT RANCH, LLC AND ROBERT L. AND CATHY VALENTA WEISE CURRENTLY HAVE PERMITTED, CERTIFICATED AND APPLICATIONS PENDING FOR, WATER RIGHTS IN THE KOBEH VALLEY BASIN WHICH HAVE EARLIER DATES OF PRIORITY THAN THE SUBJECT APPLICATION. THIS APPLICATION AND SUPPLEMENTAL APPLICATIONS BEING APPLIED FOR BY IDAHO GENERAL MINES, INC., IF APPROVED, WILL SEVERELY ENDANGER THESE AND OTHER EXISTING RIGHTS WITHIN THE KOBEH VALLEY BASIN.

PER THE NEVADA DIVISION OF WATER RESOURCES DATABASE FOR HYDROGRAPHIC BASIN 139 (KOBEH VALLEY), THE CURRENT ACTIVE ANNUAL DUTY IS 18,000 ACRE-FEET. THIS APPLICATION AND OTHERS FILED BY IDAHO GENERAL MINES, INC. WOULD SERIOUSLY DEplete THE FINITE WATER RESOURCES OF THIS DESIGNATED BASIN.
