EXHIBIT A TO PROTEST

White Pine County protests the applications filed in Butte Valley by Nevada Power Company/Sierra Pacific Power Company, application numbers 73670 through 73676, on the grounds that the points of diversion are identical to the points of diversion on White Pine County's applications, 39612, 39613, and 39632 through 39635. The applications filed by Nevada Power/Sierra Pacific Power may be detrimental to White Pine County's applications and, at this time and at the locations identified, are not in the best interests of the public.

White Pine County filed its applications for power generation in Butte Valley to facilitate location of a coal fired electrical power plant that would generate jobs, business activity, and tax revenue for White Pine County and make electrical power available in Nevada. The County has an Interim Development Agreement with LS Power to make its water permits for power generation in Steptoe Valley available for development of the White Pine Energy Station. LS Power is working diligently and spending millions of dollars on the project's development and permitting processes.

The White Pine County Commission has stated publicly that it supports the Ely Energy Center proposed by Nevada Power Company/Sierra Pacific Power Company as a second power project in the County. The White Pine County Commission voted unanimously to protest the Nevada Power Company/Sierra Pacific Power Company applications in Butte Valley, 73670 through 73676. A decision to award permits at this time and on the points of diversion identified for the County's applications could have a negative impact on the development phase of the White Pine Energy Station, jeopardizing the jobs, business activity, and tax revenue it represents for the citizens of White Pine County.

The White Pine County Commission has publicly offered to work with the Sierra Pacific Power Company to assist with project development and to identify water resources that are not in conflict with the development of the White Pine Energy Station.

The Commission respectfully requests that the State Engineer exercise his statutory authority and deny the Applications 73670 through 73676 without an administrative hearing.
