Applications 74337 through 74341

The above referenced applications propose to appropriate 11 cfs of underground water to irrigate 320 acres of land within the Smoke Creek Desert. The duty associated with these applications would be 1280 acre-feet annually based on a customary duty of 4 acre-feet per acre of irrigated land.

Pending applications 63992 through 64004, in the name of Washoe County, are on file with the State Engineer to appropriate all unappropriated water from the Smoke Creek Desert.

NRS 533.370 states that:

*The State Engineer is prohibited by law from granting an application to appropriate the public waters of State of Nevada where:*

- A. There is no unappropriated water at the proposed source;*
- B. The proposed use or change conflicts with existing rights;*
- C. The proposed use or change conflicts with protectible interests in the existing domestic wells as set forth in NRS 533.024; or*
- D. The proposed use or change threatens to prove detrimental to the public interest.*

Therefore, until applications 63992 through 64004 are denied and all appeal process have been exhausted, there is no unappropriated water in the proposed source to support applications 74334 through 74341.
