The applications referenced above request a large quantity of ground water rights for irrigation purposes within Duck Lake Valley hydrographic basin.

Washoe County has filed applications 64005 through 64009 on March 28, 1998 to appropriate all unappropriated ground water within this basin. These applications are for municipal purposes to be used within Washoe County. On December 11, 2006 Washoe County submitted information in response to requests by the State Engineer's office regarding the progress on the County applications, which are currently on file in the State Engineer's office.

NRS 533.370.5 provides that the State Engineer is prohibited from granting application if there is no unappropriated water in the proposed source of supply. Therefore based on the foregoing Washoe County requests that applications 75378 through 75384 be denied.
