

Attachment A to SNWA Protests to Cave Valley Ranch Applications

This water right application should be rejected based on the following grounds:

1. No unappropriated water exists for this water right application. This water right application is junior to applications filed in Cave Valley by SNWA, and the SNWA applications will develop the full perennial yield of these valleys. Hence, no unappropriated water is available for this application.
2. The applicant cannot establish that a beneficial use of water can be accomplished with this application.
3. The application does not present a reasonable and economical project for future growth and development in Cave Valley, and is not the type of quasi-municipal project that water should be reserved for as basin of origin demands pursuant to the Interbasin Transfer criteria in NRS 533.370.
4. Development of this application will impact the senior water rights of SNWA.
5. Approval of this application will threaten to prove detrimental to the public interest because, among other reasons, the water resources in Cave Valley are necessary for senior uses.
