

County, State of Nevada, for the following reasons and on the following grounds, to wit:

ROCK CREEK HAS RUN THROUGH OUR PROPERTY (ROCK CREEK RANCH) FOR MANY YEARS; SINCE I WAS A CHILD BACK IN THE 1940S. THE WATER FROM THIS CREEK HAS BEEN THE MAIN SOURCE OF WATER FOR OUR STOCK FOR ALL THE YEARS WE HAVE OWNED THE PROPERTY. IF THE WATER IS DIVERTED WE WILL NO LONGER HAVE A SOURCE OF STOCK WATER. DIVERSION OF ROCK CREEK WILL ALSO AFFECT THE WILDLIFE IN THAT PARTICULAR AREA, DEER, ANTELOPE, DUCKS, CHUCKAR, FISH, ETC. ROCK CREEK WATER IS ALSO THE ONLY SOURCE OF WATER FOR A CABIN ON THE NORTH SIDE OF OUR PROPERTY. OUR RANCH IS ALSO THE BASE CAMP FOR ONE OF THE NEVADA ANIMAL DAMAGE CONTROL MOUNTAIN LION SPECIALISTS, HE ALSO WORKS FOR U.S. DEPT. OF AGRICULTURE AND NDOW; HE NEEDS THE WATER FROM ROCK CREEK FOR HIS HORSES AND 18 LION DOGS.

THEREFORE the Protestant requests that the application be **DENIED**

and that an order be entered for such relief as the State Engineer deems just and proper.


