Exhibit "A"

1. There is no unappropriated water in the proposed source to support the subject Application.
2. Granting of the subject Application will conflict with and adversely impact existing rights of the Protestant and rights in and to domestic wells..
3. The proposed diversion and export of water from the source basin is not environmentally sound.
4. Upon information and belief the granting of the subject Application will result in unreasonably lowering of the static water level in the subject basin, adversely affect the quality of remaining groundwater and further threaten springs and seeps which provide water and habitat critical to the survival of wildlife and grazing livestock and other surface area existing use.
5. Use of water under the subject Application is speculative and therefore not in the public interest.
6. Applicant has not justified the need for the water that is the subject of this Application and the actual beneficial use of the water to be made as required by NRS 533.370(6).
7. Granting of the subject Application will unduly limit future growth and development of the basin of origin in violation of NRS 533.370.
8. Applicant does not possess the financial ability for developing and transporting the water to beneficial use with reasonable diligence.
