



## EXHIBIT 1

### Protest grounds

A parcel of Tribal land comprising approximately two sections exists in Township 20 North, Range 64 East, M.D.B.M. including all of Section 28 and the Western one-half of Sections 22 and 27. Former applications by the applicant, Coyote Valley Ranch LLC, namely application numbers 24315, 24814, 30258, 32119, 33205, 48702, 48703 and 63634 {WDR} were approved without our knowledge and are immediately contiguous to our parcel boundary. Now this protest application, number, as well as four others, are currently being proposed, again in close proximity to our Parcel boundary. The Ely Shoshone Tribe intends to develop this property in an un-disclosed commercial venture in the near future. With the on going mining of the Tribe's groundwater hydrologic conditions may already exist or will begin to that will preclude our economic development of our groundwater resources. To further add to conditions when groundwater is mined, a portion of the aquifer(s) collapse and can never rebound. With the extent, amount, amount over time and dispersion of the existing wells significant irreparable damage to the aquifer under our parcel may have already occurred. With the approval of this application, not to mention the other pending four, the cumulative effects cannot help but to be significant. The Tribe is aware of our Winters Doctrine rights, effective through the Ruby Valley Treaty of 1873. The water underlying our Parcel falls under that domain. The preceding facts are presented to set the stage for the issues as follows;

A study is needed to ascertain the existing hydrologic and geo-hydrologic conditions as they exist today. This means test wells need to be bored that are capable of measuring the static, dynamic conditions, the aquifers permeability and porosity. The fluid dynamics of this specific area was not discussed in depth in the BARCASS Study nor the re-charge basin specifics been investigated. The applicant must provide factual evidence that can be entered into the record that addresses these concerns. Recourse for prior ground water mining by the Applicant may not be reversible but future damage is preventable.

Interesting to note is the cumulative amount of water withdrawal. Discussions with irrigation companies shows that the quantity of water withdrawn exceeds the amount needed solely for irrigation. We do not want our water mined and sold to power plants or Las Vegas. If a clandestine attempt to do this exists, it must be stopped right now. Also, serious questions exists regarding the establishment of a subdivision or mini- hobby ranches on this adjoining property. One term and condition of approval could be the imposition that the water withdrawn be used in perpetuity on the subject parcels and strictly be prohibiting the sale of these waters for any other purpose.

Other tangential issues exist with the down slope effects on the riparian and avian communities that lie in the bottom lands. With Pumping the capillary fringe will sink deeper causing a alteration of plant life, food and cover for animal life. This will occur. Yet another result occurs with pumping, the aquifer collapses over time with concentric collapse features occurring around the well head and pore space collapse underground. As you will note, the cumulative effect of this application, it's implications on the natural environment , the potential legal ramifications, and economic costs of pumping water from an ever increasing depth and water quality issues to the above ground intermittent fluvial recharge channels are to many effects to ignore. A major study and review of this project is demanded prior to any decision being made. There is not enough evidence in the record to warrant a decision based on the information set forth in this application.
