

Mr. Tracy:

I am a grazing permittee on the above referenced BLM allotment and thereby entitled to protest the applications filed by the DOE on said allotments as follows;


Applications numbered 77813, 77814 & 77815. - *77816*

If approved these wells could have the potential to adversely affect my existing, senior in priority, water rights, V04398, V04399, 39270, 48184, 48410, 52000 & 65563.

I am concerned that use from these new sources could have the effect of lowering the water table to the extent that the springs that we rely on for our livestock grazing could begin to "dry up" or become otherwise unavailable for our use. There is also a possibility for contamination to the underground aquifer, which is of concern.

I hereby request a hearing on these applications and to be notified of the scheduling if and when said hearings are held to discuss these issues and possible options.
