



County, State of Nevada, for the following reasons and on the following grounds, to wit:

1. The description of proposed works given in Application 78328 does not adequately address how the spring will be developed to transfer water from Unnamed Spring No. 13 to a pipe then into troughs. 2. Applicant does not possess permission from the Bureau to construct any facilities on public land. 3. It is not clear how much water, if any, is available for diversion from Unnamed Spring No. 13. Application 78328 is one of three applications for water from Spring Number 13 for a total balance of 0.4234 cfs. After an initial Bureau assessment of Spring Number 13, the Bureau questions if there is sufficient flow for application 78328 (0.0234 cfs) let alone all three applications. 4. Removal of any water from Unnamed Spring No. 13 would prove detrimental to the public interest by de-watering the riparian habitat established around the spring and threaten wildlife species dependent upon the spring for water, food, and cover. Riparian habitat is extremely rare and valuable to wildlife species on public lands in eastern White Pine County.

THEREFORE the Protestant requests that the application be Denied

Denied, issued subject to prior rights, etc., as the case may be

and that an order be entered for such relief as the State Engineer deems just and proper.


