



**ADDITIONAL INFORMATION TO SUPPORT THE PROTEST
OF THE U.S. FISH AND WILDLIFE SERVICE
IN THE MATTER OF APPLICATIONS 79320-79322**

Application Nos. 79320 through 79322 were filed by the Southern Nevada Water Authority on January 28, 2010 requesting a combined diversion rate of 26 cubic feet per second (18,823 ac-ft annually) from an underground source in Tikapoo Valley North, groundwater basin 169A. The purpose of the proposed applications is municipal use. Basin 169A is part of the Death Valley Regional Groundwater Flow System. The proposed groundwater wells are located up gradient from Desert and Ash Meadows National Wildlife Refuges (NWRs) and the Devil's Hole Unit of Death Valley National Park.

The U.S. Fish and Wildlife Service (Service) requests that Application Nos. 79320 through 79322 be denied because:

1. Water is not available to appropriate in the manner described.
2. Granting of these applications will cause injury to Service-owned senior water rights for water on the Fish Springs NWR.
3. The proposed activity is not likely compatible with the purposes of the national wildlife refuges. Granting of these applications will threaten or damage habitat for species that are endangered, threatened, or considered for future listing under the Endangered Species Act and, therefore, is not in the public interest.

According to the Basin Summary for Basin 169A from the State Engineer's Office, the perennial yield is 2,600 ac-ft annually. The sum of the applied-for volume and the existing water rights exceeds the perennial yield for this basin.

The Service is also concerned about impacts to senior water rights at Desert and Ash Meadows NWRs. Both NWRs are supported by groundwater discharge from the regional carbonate aquifer and all of the current spring discharges and associated surface water are protected through senior state appropriative water rights. Applications 79320 through 79322 have the potential to unreasonably impact these senior water rights.

The proposed groundwater development is not in the public interest. The impacts from the proposed diversions will eventually and inevitably impact biological resources and endangered species at Desert and Ash Meadows NWRs and other locations in the Death Valley Regional Groundwater Flow System.
