

County, State of Nevada, for the following reasons and on the following grounds, to wit:

concerns that the pumping of subsurface waters will adversely affect and waters of the Butterfield grazing allotment specifically and further, will adversely affect the subsurface and surface waters of Railroad Valley for the beneficial use of communities and individuals who reside in Nye County where the waters are located

Despite the obvious detrimental effects, it seems morally and ethically wrong to move massive amounts of fresh water from one basin to another thru a pipeline, sending it hundreds of miles closer to the ocean.

However, there is justice in sending some of the harmful radiation back to where it came from.

Protestant reserves the right to amend this protest to include issues as they develop.

THEREFORE the Protestant requests that the application be denied

and that an order be entered for such relief as the State Engineer deems just and proper.
