**Formal Protest Requesting Denial of Application No. 81331**  
**Applicant – Gary Snow Livestock and Grain**

Gary Snow Livestock and Grain, under Application No. 81331 proposes to utilize groundwater in the amount of 0.1 cubic feet per second (cfs) of water from Black Rock Well for stock watering for seven (7) months of the year from the Ralston Valley Hydrographic Groundwater Basin No. 141.

A request for denial is based on the following concerns:

Nye County and the Town of Tonopah have always been active in groundwater and surface water management issues regarding the Ralston Valley Hydrographic Basin and surrounding basins. At this time, the only municipal water source for the Town of Tonopah is supplied from a well field located in the Ralston Valley Hydrographic Basin.

The Town of Tonopah/Tonopah Public Utilities, a water right owner within Ralston Valley Basin 141, protests this application for the following reasons:

1. The State Water Engineer issued a Notice of Curtailment of Water Appropriation and Designation of Preferred Use of Ground Water on August 15, 1980, and also issued Ruling 5243 on May 9, 2003, with regard to the Ralston Valley Ground Water Basin.
2. The Town of Tonopah Wellhead Protection Program established in May 2005 as required by Nevada Department of Environmental Protection.
3. The Town of Tonopah/Tonopah Public Utilities believes that when one entity or individual, is granted or has been granted a water right by the State Water Engineer, and then develops that right, then that individual or entity owns that right until they forfeit, sell, or relinquish the right. When another entity or individual who desires to use that right and all of the associated improvements such as: wells, pipes, pumps, right of ways, etc., that entity must have the permission from the original grantee or the existing water right holder. If the State Water Engineer grants water rights to an applicant who only has to file over existing improvements in order to use those existing improvements or infrastructure for their gain, the Town of Tonopah believes that its investment in developing water rights and infrastructure to provide safe and reliable drinking water to the Town of Tonopah, could be filed on by any entity or individual and then used by any entity or individual without the Town's permission. The Town of Tonopah believes this sets a dangerous precedence for the State of Nevada.
