Subject: Protest of Application 81524-81532 - TRI General Improvement District

Dear Jason:

The Bureau of Reclamation has reviewed, and hereby protests, Application Nos. 81524-81532 filed by TRI General Improvement District. Application numbers 81524-81532 seek to appropriate groundwater from the Tracy Segment Hydrographic Basin which is a fully-appropriated basin. Applications 81524-81532 should be denied on the basis that there is no unappropriated water at the proposed source. State Engineer's ruling numbers 5747 and 5749 have denied other applications attempting to appropriate groundwater in the Tracy Segment Hydrographic Basin on the basis that there is no additional groundwater available for appropriation.

Granting the applications would result in the withdrawal of groundwater in excess of the perennial yield of the Tracy Segment Hydrographic Basin; and therefore, would adversely affect existing rights and would be detrimental to the public interest.

Granting the applications would be detrimental to the United States, to the Newlands Project, and the public interest by depleting flows in the Truckee River due to the connection between groundwater and surface water in the basin. Depleted Truckee River flows would operate to the detriment of the threatened and endangered species inhabiting Pyramid Lake and the lower Truckee River and reduce surface flows available under Claim 3 of the Orr Ditch Decree.

Granting the applications may otherwise prove to be contrary to law or the public interest as cannot yet be determined based on the information in the applications.

Enclosed are Reclamation's protests, filed in duplicate, with a check for the \$225.00 filing fee.




