County, State of Nevada, for the following reasons and on the following grounds, to wit:

1)Water speculation-At a public meeting 12/13/12.Wendovers spokesman stated-we do not need this water now-perhaps in 50yrs.2)Also learned then-Wendovers can not afford this project now. Applicant has not demonstrated good faith intent,financial ability,reasonable expectation to construct & apply the water to the intended beneficial use in a timely manner.3)Applicant has not implemented a sufficient conservation plan.4)Applicant has not justified the need to import water from another basin.5)Appropriation & export of water would be detrimental to public interest on economic grounds & would unduly limit future growth & development in Pilot Valley.6)Detrimental on environmental grounds in Pilot Valley-harm to wildlife & habitat.7)Application & proposed use would conflict with existing rights & protectable interests in domestic &/or ranch production &/or wells.8)There is insufficient water available in PV191.Report 56 is 42yrs old.9)Protestant reserves the right to amend this protest to include issues as they develop.

and that an order be entered for such relief as the State Engineer deems just and proper.


