IT WILL ALLOW USE DURING THE PERIOD FROM 11/1 TO 04/1 WHEN THE AQUIFER IS NORMALLY RECHARGING. WE ARE IN A PERIOD OF DROUGHT CONDITION WITH NO END IN SIGHT. THE WATER RIGHTS IN THE VALLEY ARE ALREADY OVERALLOCATED AND THE WATER TABLE IS DROPPING. THIS WELL IS IN THE SOUTH BASIN AREA AND HISTORICALLY MOVEMENT OF WATER TO THE NORTH BASIN AREA HAS NOT BEEN ALLOWED AND CHANGING THE WELL [REDACTED] TO COMMERCIAL WILL START US DOWN A SLIPPERY SLOPE TO MOVE ADDITIONAL RIGHTED WATER TO THE DIVERSION POINT FOR USE AT THE SMITH VALLEY FARMS PROJECT WHICH WILL REQUIRE AN ENORMOUS AMOUNT OF WATER 365 DAYS A YEAR.
