PROTEST

Comes now City of Fernley

of Application Number 83254, filed on November 15, 2013
by Tahoe Reno Industrial Center, LLC for the
waters of Truckee River situated in Storey
an underground source or name of stream, lake, spring or other source

County, State of Nevada, for the following reasons and on the following grounds, to wit:
The point of diversion is being changed from a surface ditch diversion in Washoe County to a downstream induction well diversion located in Storey County. While the City of Fernley does not disagree with the concept of moving water rights downstream from upstream decreed points of diversion, the City is concerned that the proposed change as requested might increase the amount of water withdrawn from the river than would have been allowed under the base right. The pumping from the proposed induction well needs to be regulated to a degree that ensures the applicant receives only the flows and duty to which they are entitled to receive under the base right at any given time. Any changes or increases in diversion rate or duty than was received under the decreed right would conflict with existing downstream rights, including those owned by the City of Fernley and its citizens.

THEREFORE the Protestant requests that the application be subject to the protest grounds and subject to prior rights
Denied, issued subject to prior rights, etc., as the case may be
and that an order be entered for such relief as the State Engineer deems just and proper.
