





County, State of Nevada, for the following reasons and on the following grounds, to wit:

- 1) The Applicants do not have a "Project" for utilizing water for this Application. They describe a historical use of overflow, when in fact very little water has (historically) "overflowed" because of constant diversion and use of the water by the Vested Right holder at Home Station Ranch. 2) The location of Jersey Hot Spring "F" is just outside the Horse Management Area (HMA) outlined by the U. S. Bureau of Land Management. Therefore, the State Engineer, by his own statues and/or policy, cannot issue a water right for wild horses outside a designated HMA. 3) They are not an Entity actively engaged in wildlife management. If the Nevada Department of Wildlife and/or the BLM wish to furnish water per this Application those entities should do so. Please refer to NRS 533.370 1 (c) 1 and 2. 4) Under 533.370 4 (h) the Applicant does not have authorization from a government agency to divert water from the source on public lands.


