waters of Casey Hot Springs well situated in Humboldt

an underground source or name of stream, lake, spring or other source

County, State of Nevada, for the following reasons and on the following grounds, to wit:

There is no beneficial use for this water, the application is based on pure speculation which is illegal under Nevada law. The application in conjunction with another application (84430) by the applicant exceeds the maximum amount of unappropriated water at the source. Use of the water under the proposed application would prove detrimental to the public interest in that it would remove water from a National Conservation Area (NCA), which are public lands, degrading the NCA and public enjoyment of such by negatively impacting wild lands and wildlife resources upon which the NCA was established. The proposed action is not environmentally sound as several threatened or endangered species are dependent on the surface waters of nearby hot springs that would almost certainly be impacted by the project. A pipeline necessary for inter-county transfer of the water would further negatively impact the NCA and the public enjoyment of such by severely detracting from the area's current natural state. The project would limit future growth and agricultural use.

THEREFORE the Protestant requests that the application be denied

Denied, issued subject to prior rights, etc., as the case may be

and that an order be entered for such relief as the State Engineer deems just and proper.
