Mr. King:

I am writing to you in protest of Steven and Staci Egger's application to appropriate and change the point of diversion of waters in the Quinn River Valley. The valley that we live in along with the Eggers and many more farmers and ranchers is a closed basin and has been for some time.

The Woodward Ranch (Rob and Delia Nuffer) is soon to be in the same family for 100 years (2019). A number of the neighboring ranches were started by or increased their acreage by applying or buying former Desert Land Entry properties, which is also the case with parts of our ranch. Then the Taylor Grazing Act was created and we now have the BLM and Forest Service which I am sure you are well aware of. The AUMs (Animal Unit Months) that make up these holdings have a dollar value that is pertinent to the value of our ranch as well as the success of our livelihood.

The Eggers have decided that they need more land to raise alfalfa so they have applied for a DLE which would take in 1100 acres of BLM permitted ground of which 450 acres belong to the Woodward Ranch and is part of our BLM permit. The water they wish to appropriate or change point of diversion is directed to these permitted acres.



It is drawing close to irrigation time and Eggers nearby neighbors are anticipating evidence of his pumps drawing their irrigation wells down.

At this time we have a formal protest in the office of the Dept of Interior in Washington D.C. as well as the State Office in Reno, NV. It may also be of some value to you to check with the Humboldt County Commissioners because they are very well aware of the ways and means that the Eggers have taken to try and obtain this piece of property. I believe that you will find that the BLM actions on this subject have been questionable. We ask you to consider this protest along with the many others that I know have been sent to your office.

GENERAL:

Application 30219 was filed on May 5, 1976 by Vernon Cannon to appropriate 2.5 cfs of the waters of an underground source to be diverted within the NE $\frac{1}{4}$ SW $\frac{1}{4}$ Section 2, T.41N., R.32E. and to be used for the irrigation of 360 acres within the NW $\frac{1}{4}$ SE $\frac{1}{4}$ and SW $\frac{1}{4}$ Section 2, SE $\frac{1}{4}$ Section 3 T.41N., R.32E.

This application was protested on June 7, 1976 by Jule and Elizabeth DeLong.

An investigation in the matter of application 30219 was made on September 22, 1976.


OPINION:

The protest to the granting of Application 30219 is hereby sustained and the application is hereby denied on the grounds that it would tend to impair the value of existing rights.



NOTICE OF CURTAILMENT OF WATER
APPROPRIATION WITHIN THE DESIGNATED
PINE FOREST VALLEY GROUND WATER BASIN

The State Engineer designated the Pine Forest Valley Ground Water Basin, as provided under NRS 534.010 to 534.190, inclusive, by Order No. 711 dated May 1, 1978.

Crop and pumpage inventories maintained by the office of the State Engineer indicate that present withdrawals are exceeding the estimated recharge of the Pine Forest Valley Ground Water Basin.

The irrigation of additional land using underground water would threaten to impair the value of existing underground and surface water rights.

In accordance with NRS 534.120, subsection 2, the irrigation of additional land using underground water is not considered to be a preferred use of the limited underground water resource.

NOW THEREFORE, it is ordered that:

All applications filed after December 1, 1983, to appropriate underground water to irrigate additional land within the Designated Pine Forest Valley Ground Water Basin will be denied.
