



County, State of Nevada, for the following reasons and on the following grounds, to wit: AS THE OWNER OF WATER RIGHTS TO BOTH THE NORTH + SOUTH SPLIT OF SHERIDAN CREEK, I OBJECT TO THE APPLICANTS ATTEMPT TO DIVERT WATER FROM THE VOLUNTARY ROTATION OF THE SOUTH SPLIT TO HIS CONTINUOUS USE FOR HIS CONSUMPTIVE PONDS ON THE NORTH SPLIT. THE NORTH SPLIT IS ON A COURT ORDERED ROTATION WITH NO CONTINUOUS USE IN THE IRRIGATION SEASON. THERE IS INADEQUATE WATER IN SHERIDAN CREEK TO SERVICE ITS RANCH LANDS WITHOUT USING MORE WATER TO THE PONDS.

THEREFORE the Protestant requests that the application be DENIED

and that an order be entered for such relief as the State Engineer deems just and proper.
