

County, State of Nevada, for the following reasons and on the following grounds, to wit:

1) Approval of the application would conflict with existing rights, including Certificate No. 10211.

2) Approval of the application would threaten to prove detrimental to the public interest.

a) The application is located within the Dry Lake Use Area of the Wilson Creek Allotment managed by the U.S. Bureau of Land Management. SNWA is one of the grazing permit holders on the Dry Lake Use Area and is filing this protest to secure a seat at the table for discussion of water management issues on the allotment.

b) The application requests nine times more water than can be beneficially used by 905 cattle.

THEREFORE the Protestant requests that the application be

denied

Denied, issued subject to prior rights, etc., as the case may be

and that an order be entered for such relief as the State Engineer deems just and proper.


