Pahrump Utility Company, Inc. (PUCI) is the owner of water rights that were previously dedicated to PUCI by B-PVL2, LLC for property that is within PUCI's service territory. Applications 84884 and 84886 propose to move a large quantity of water rights (746.9 acre feet) to a well location in the northeast quarter of Section 3, which is up gradient of and in close proximity to PUCI's CAAS Well #2 and Manse Well #1. The Applicant's proposed well is also up gradient of several other wells in PUCI's service territory and will intercept groundwater flow to those wells. The proposed change application will have an adverse affect on PUCI's wells and service territory and should be denied.


