

PROTEST

County, State of Nevada, for the following reasons and on the following grounds, to wit:

This application 85263, and the associated application 85264, are revised versions of applications 84429 and 84430, made in 2014. The only difference is that the applicant has compiled a list of "potential" beneficial uses. We hold that the list lacks any detail that would suggest there is a need for the water to be conveyed from the sources. These applications again are based on pure speculation which is illegal under Nevada law. The application in conjunction with the associated application (85264) exceeds the maximum amount of unappropriated water at the source. Use of the water under the proposed application would prove detrimental to the public interest in that it would remove water from a National Conservation Area (NCA), which are public lands, degrading the NCA and public enjoyment of such by negatively impacting wild lands and wildlife resources upon which the NCA was established. The proposed action is not environmentally sound as several threatened or endangered species are dependent on the surface waters of nearby springs.

THEREFORE the Protestant requests that the application be denied

Denied, issued subject to prior rights, etc., as the case may be

and that an order be entered for such relief as the State Engineer deems just and proper.
