GENERAL

Application 36268 was filed on December 11, 1978, by Walter L. and Tommye J. Plaskett to appropriate 10.8 c.f.s. of the waters of an underground source to be diverted within the SW $\frac{1}{4}$ NE $\frac{1}{4}$ Section 1, T.21N., R.53E., M.D.B.&M., to be used for the irrigation of 662 acres of land in said Section 1.

FINDINGS OF FACT

I

The land to be irrigated lies within that area designated and described as the Diamond Valley Ground Water Basin by Orders of the State Engineer Nos. 277 and 280 signed on August 5, 1964, and August 28, 1964, respectively. 1/

II

640.2 acres of the land proposed to be irrigated under Application 36268 has an existing water right evidenced by Permit 19563, Certificate 6258, in the amount of 5.4 c.f.s.; Permit 19971, Certificate 8082, in the amount of 2.101 c.f.s.; Permit 19972, Certificate 6241, in the amount of 1.461 c.f.s.; Permit 19973, Certificate 6242, in the amount of 3.12 c.f.s.; Permit 28160, Certificate 9043, in the amount of 1.337 c.f.s.; and Permit 34948 in the amount of 2.2 c.f.s.

III

The proposed point of diversion of Application 36268 is the existing well drilled under Permit 19971. 3/

IV

Notice of Curtailment of Water Appropriation within the Diamond Valley Ground Water Basin was issued by Order of the State Engineer on December 22, 1975. (Order No. 541) This order provides:

- "1. All applications filed to appropriate water from the Diamond Valley Ground Water Basin north of the South Boundary Line of Township 22 North, M.D.B.&M. will be considered for approval on an individual basis and on their own merits.
2. All applications filed to appropriate water for irrigation of additional lands within that portion of the designated area of Diamond Valley south of the South Boundary Line of Township 22 North M.D.B.&M. that have not had a previous water right lost through forfeiture will be denied.

3. All applications filed to appropriate water for irrigation purposes on lands in Diamond Valley that had a previous water right lost through forfeiture will be considered for approval on an individual basis and on their own merit." 4/

V

Notice of Curtailment of Water Appropriation within the Diamond Valley Ground Water Basin was issued by Order of the State Engineer on July 10, 1978. (Order No. 717) This order provides:

- "1. All applications filed after the date of this order to appropriate ground water for irrigation of lands within the Diamond Valley Ground Water Basin that have not had a previous water right lost through forfeiture will be denied.
2. All applications filed on or before December 31, 1978, to appropriate ground water for irrigation purposes on lands in Diamond Valley that had a previous water right lost through forfeiture will be considered for approval on an individual basis and on their own merits.
3. All applications filed after December 31, 1978, to appropriate ground water for irrigation purposes on any land within the Diamond Valley Ground Water Basin will be denied." 5/

CONCLUSIONS

I

The State Engineer has jurisdiction of the parties of the subject matter of this action. 6/

II

The land proposed to be irrigated has an existing right that has not been lost through forfeiture. 7/

RULING

Application 36268 is hereby denied on the grounds that the land proposed to be irrigated is presently covered with water rights for the irrigation of said land under existing Permit 19563, Certificate 6258, Permit 19971, Certificate 8082, Permit 19972, Certificate 6241, Permit 19973, Certificate 6242, Permit 28160, Certificate 9043, and Permit 34948

and the granting of Application 36268 would constitute an additional diversion of water from this concentrated area which would adversely affect existing rights and be detrimental to the public welfare.
