RULING 2962

GENERAL

Application 42304¹ was filed on August 28, 1980, by Susan L. Cash to appropriate 5.4 c.f.s. of water from an underground source to irrigate 320 acres of land within the E1/2 Section 6, T.11N., R.67E., M.D.B.&M. The point of diversion is described as being within the SW1/4 NE1/4 Section 6, T.11N., R.67E., M.D.B.&M.

Application 42305¹ was filed on August 28, 1980, by Susan L. Cash to appropriate 5.4 c.f.s. of water from an underground source to irrigate 320 acres of land within the E1/2 Section 6, T.11N., R.67E., M.D.B.&M. The point of diversion is described as being within the SW1/4 SE1/4 Section 6, T.11N., R.67E., M.D.B.&M.

Application 42312¹ was filed on August 28, 1980, by Michael P. Sparks to appropriate 5.4 c.f.s. of water from an underground source to irrigate 320 acres of land within the W1/2 Section 18, T.12N., R.67E., M.D.B.&M. The point of diversion is described as being within the SW1/4 SW1/4 Section 18, T.12N., R.67E., M.D.B.&M.

Application 42313¹ was filed on August 28, 1980, by Michael P. Sparks to appropriate 5.4 c.f.s. of water from an underground source to irrigate 320 acres of land within the W1/2 Section 18, T.12N., R.67E., M.D.B.&M. The point of diversion is described as being within the SW1/4 NW1/4 Section 18, T.12N., R.67E., M.D.B.&M.

FINDINGS

I.

Records and information² available to the State Engineer indicate that Applications 42304, 42305, 42312 and 42313 were filed in support of Desert Land Entry applications.

II.

By letter³ dated July 21, 1982, the United States Department of Interior, Bureau of Land Management, notified the State Engineer that the following Desert Land Entry Applications had been closed and the case files are dead.

III.

The applicants under Applications 42304, 42305, 42312 and 42313 do not own or control the land described under the place of use of the applications.

CONCLUSIONS

I.

The State Engineer has jurisdiction⁴ over the matter described herein.

II.

Applications 42304, 42305, 42312 and 42313 were filed in support of Desert Land Entries. The Desert Land Entry applications described under II of Findings have been closed on the records of the Bureau of Land Management, therefore, the applicants do not own or control the land described under the place of use of the applications and cannot demonstrate the ability to place the water to beneficial use.

III.

To grant applications to appropriate the public waters for irrigation on lands the applicant does not own or control or where the applicant cannot demonstrate the ability to place the water to beneficial use, would not be in the public interest and welfare.

RULING

Applications 42304, 42305, 42312 and 42313 are herewith denied on the grounds that to grant the applications for irrigation purposes on lands that the applicant does not own or control and cannot demonstrate the ability to place the water to beneficial use, would not be in the public interest and welfare.
