FINDING OF FACT

An application for a Nevada Well Driller's License was filed by William Wayne Wiewel in the Office of the State Engineer on September 13, 1993 together with the statutory filing fee of \$100.00. Receipt No. 12249 was issued to Welch & Howell Drilling, Inc. for said filing fee.

Requests for four references were mailed on September 13, 1993. References were received from four of the requests. The applicant was notified on September 22, 1993 by certified mail to appear before the Statewide Well Drillers' Advisory Board on October 15, 1993 at 8:30 A.M. in Las Vegas, Nevada.<sup>1</sup> The certified mail receipt was signed by Breannu Wiewel on September 28, 1993. The applicant telephoned the State Engineers' Office October 13, 1993 and cancelled his examination.

The applicant was notified on November 30, 1993 by certified mail to appear before the Board on December 9, 1993 at 10:00 a.m. in Las Vegas, Nevada. He telephoned the State Engineers' Office on December 8, 1993 to cancel his examination and request to be examined in January.<sup>1</sup>

The applicant was again notified on March 15, 1994, by certified mail to appear before the Board on April 15, 1994 at 8:00 a.m. in Las Vegas, Nevada. He telephoned the State Engineer's Office on April 12, 1994 to cancel his examination and requested to be examined in July.<sup>1</sup>

The applicant was notified on June 23, 1994 by certified mail to appear before the Board on July 14, 1994 at 8:00 a.m. in Las Vegas, Nevada and was advised in this letter that if he cancelled this examination date, he would be noticed once more for examination, and if he cancelled that examination (the 5th) the Board would consider denial of his license application. He telephoned the State Engineers' Office on July 13, 1994 to cancel his examination.<sup>1</sup>

The applicant was notified on September 12, 1994 by certified mail to appear before the Board on October 14, 1994 at 8:00 a.m. in Las Vegas, Nevada. He was advised in this letter that if he cancelled this examination the Board would recommend that his application be denied. He telephoned October 13, 1994 to advise that he was not going to take the test and request an application form to re-apply for a license.<sup>1</sup>

The applicant did not appear as requested for examination. The Statewide Well Driller's Advisory Board recommended denial of the application of William Wayne Wiewel on October 14, 1994.<sup>2</sup>

RULING

The State Engineer concurs with the recommendation of the Board and the application of William Wayne Wiewel is herewith denied on the grounds that the applicant failed to appear as scheduled to substantiate his experience and ability as a water well driller.
