

Dear Dean,

This is to inform you that we have cemented wells number one, two and three at Sierra Vista Rancho on Tomyiasu, as per state regulations.

Each well had a line shaft turbine pump, which we removed prior to cementing. Well #2 had a liner installed recently and therefore did not require perforating. We placed the concrete with the use of a trim pipe and used approximately 7 1/2 yards.

We found that the casing at well #1 had deteriorated to the point where it was impossible to perforate. We also placed the concrete via a trim pipe and used approximately 16 yards.

Well #3 had numerous breaks in the casing and therefore we were unable to perforate. We again placed the concrete using a trim pipe, and used approximately 13 yards. The complete plugging process for all three wells was performed over a 10 day period.


