RE: Request for waiver to install one (1) monitor well within a **nondesignated basin** (Oasis Valley Basin) located within the SE¼ of the NE¼ of Section 28, T.10S, R.46E (UTM Easting: 515500.0 UTM Northing 4,099,190.0, NAD 27), and within the Oasis Valley Basin (228).

Dear Mr. Brechtel:

As provided in Nevada Administrative Code (NAC) § 534.450 of the Regulation for Water Well and Related Drilling, permission is herewith granted to install the subject well to measure the groundwater as described in your request received August 14, 2013. Your statement ensuring the Corvus Gold Nevada, Inc. responsibility for abandonment of these wells upon project completion was received in this office on August 14, 2013.

This request is also based on NAC § 534.310 (3)(c): Nondesignated basins which states, "In basins which have not been designated by the State Engineer, a waiver is required for any water well: That may be used as a monitor well." This waiver is hereby issued in accordance to NAC § 534.310 (3)(c), allowing you to install the subject well within a nondesignated basin (Basin 228).

The purpose of this monitor well is to collect baseline data for the North Bullfrog Project on the groundwater levels and water quality in the vicinity of the Bullfrog Hills, Basin 228, Nye County, Nevada. The wellhead shall be protected from damage due to vandalism or sunlight. The well may be completed with ASTM F-480 (Sch. 40 or heavier) well casing as provided in NAC § 534.362.

Glued casing joint connections will not be allowed. Full compliance with the remainder of the statute and regulation is required.

A plot map showing the actual location of the completed wells must be submitted upon completion of the drilling operations. Please include an accurate description of the location of the wells and piezometers on the completion reports (GPS coordinates are required).

The well driller's reports shall bear this waiver number: MO-2966.

Authorization to drill under this waiver expires one (1) year from the date of this letter.

The well driller must have a copy of this waiver in possession at all times during drilling activities pertaining to this project. This well may only be pumped when necessary to obtain samples.

Please note that you must notify the Nevada Division of Environmental Protection (NDEP) for possible permitting requirements for groundwater or temporary surface discharge permits, which may include Underground Injection Control (UIC) or National Pollution Discharge Elimination System (NPDES) Permit Numbers. For more information regarding the permitting process with NDEP, please contact Mr. Alex Lanza at (775) 687-9468.


All wells shall be plugged and abandoned, as provided by regulation, upon project completion. The current owner of the non-assessed parcel listed on the previous page is shown as Bureau Land Management by the records of the Nye County Assessor's office. This waiver does not imply or grant any land use agreements between Bureau Land Management and any land owners. It is expressly understood that this authorization does not relieve the operator of the requirements of any other state, federal or local agencies.
