Spent two days with backhoe to locate well. We found it 8' below ground level and found it was filled up with dirt. Placed a 10"x8' long conductor pipe over the 8" casing and back filled to ground level. Placed drilling rig over hole and drilled out dirt down to 25'; from 25' to 37' we found wood, bottles, trash etc. At 37' we broke into open hole down to 70'. @ 70' we encountered 6" liner that was partially closed. Drilled on iron approx. 1 hour before entering the 6" casing at 79' From 79' to 160' was open hole. We then placed a trimatic @ 155' and place 4.5 yards of mix W171. Perforate from 155' to 85' with air perforator. Then removed conductor.
