This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the Place of Use of a portion of the waters of the Truckee River as heretofore granted under Claims Nos. 75 and 75A, Truckee River Final Decree, is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.667 cubic feet per second, or 191 acre-feet annually.

Actual construction work shall begin on or before April 24, 1975

Proof of commencement of work shall be filed before May 24, 1975

Work must be prosecuted with reasonable diligence and be completed on or before April 24, 1976

Proof of completion of work shall be filed before May 24, 1976

Application of water to beneficial use shall be made on or before April 24, 1977

Proof of the application of water to beneficial use shall be filed on or before May 24, 1977
