This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the

following limitations and conditions: This permit to change the Place of Use of a portion of the waters of the Truckee River (Steamboat Canal) as heretofore granted under Permit 20304 is issued subject to the terms and conditions imposed in said Permit 20304 and with the understanding that no other rights on the source will be affected by the change proposed herein. A substantial headgate and measuring device must be installed and maintained to facilitate the measurement and control of water. The State reserves the right to regulate the use of the water under this proposed change at any and all times.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.258 cubic feet per second, but not to exceed 58.23 acre-feet annually.

Actual construction work shall begin on or before July 4, 1974

Proof of commencement of work shall be filed before August 4, 1974

Work must be prosecuted with reasonable diligence and be completed on or before July 4, 1975

Proof of completion of work shall be filed before August 4, 1975

Application of water to beneficial use shall be made on or before July 4, 1976

Proof of the application of water to beneficial use shall be filed on or before August 4, 1976

Map in support of proof of beneficial use shall be filed on or before August 4, 1976
