1. The source of water is Underground - Well 8 Name of stream, lake, underground spring or other source.

2. The amount of water to be changed 1.18 c.f.s., 261.35 acre-feet Second feet, acre feet. One second foot equals 448.83 gallons per minute.

3. The water to be used for Municipal Irrigation, power, mining, industrial, etc. If for stock state number and kind of animals.

4. The water heretofore permitted for Municipal Irrigation, power, mining, industrial, etc. If for stock state number and kind of animals.

The existing permitted point of diversion is located within NE 1/4 NE 1/4 Section 26, T.20 S., R.53 E., M.D.B. & M., or at a point from which the E 1/4 corner of Section 23, T.20 S., R.53 E., M.D.B.&M., bears North 4°00' East, a distance of 2750 feet (Well 17) If point of diversion is not changed, do not answer.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 46328, is issued subject to the terms and conditions imposed in said Permit 46328, and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 38343, 45581, 45870, 45892, 45893, 45894, 45895, 45897, 46116, 46117, 46118, 46119, 46303, 46304, 46305, 46306, 46307, 46308, 46309, 46310, 46312, 46313, 46314, 46315, 46316, 46317, 46318, 46319, 46320, 46321, 46322, 46323, 46324, 46325, 46326, 46331, 46332, 46826, 46827, 47074, 47141, 47265, 48497, 49545, 50722, 50804, 50805, 52128, 52129, 52130, 52131, 52132, 52284, 52285, 52286, 52606, 52978 and 52980 shall not exceed 18075.74 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.18 cubic feet per second, but not to exceed 261.35 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before APRIL 17, 1990

Proof of completion of work shall be filed before MAY 17, 1990

Application of water to beneficial use shall be made on or before APRIL 17, 1990

Proof of the application of water to beneficial use shall be filed on or before MAY 17, 1990

Map in support of proof of beneficial use shall be filed on or before MAY 17, 1990
