The applicant Washoe County, a Political Subdivision of the State of Nevada hereby make application for permission to change the Point of Diversion, Manner and Place of Use of a Portion of water heretofore appropriated under a portion of Claims 474/475 of the Truckee River Decree, said Decree entered by the District Court of the United States in and for the District of Nevada in that certain action entitled "The United States of America, Plaintiff VS. Orr Water Ditch Co., et al, Defendants," Equity Docket No. A-3.

1. The source of water is Truckee River
2. The amount of water to be changed 14.324 Acre Feet - 0.09 cfs
3. The water to be used for Municipal
4. The water heretofore permitted for AS Decreed
5. The water is to be diverted at the following point See Exhibit "A"
6. The existing permitted point of diversion is located within NW 1/4 SE 1/4, Section 11, T19N, R19E, MDM, or at a Point from which the SW corner of said Section 11 bears S69° 15'W a distance of 3640.0 feet (Cochran Ditch)
7. Proposed place of use See Exhibit "B" and supporting maps filed under Applications 57410 and 62187.
8. Existing place of use 2.137 acres in the NW NE; 0.344 acres in the NE 1/4 NE 1/4; and 1.10 acres in the SE NE, Section 30, T19N, R19E, MDM. (3.581 acres - 14.324 AF)
9. Use will be from As Decreed to As Decreed of each year.
10. Use was permitted from As Decreed to As Decreed of each year.
11. Description of proposed works Water will be diverted by existing facilities, treated and placed into existing distribution systems.
12. Estimated cost of works Existing
13. Estimated time required to construct works Existing
14. Estimated time required to complete the application of water to beneficial use 5 years

This permit to change the point of diversion, place of use and manner of use of a portion of the waters of the Truckee River as heretofore granted under Claims 474 and 475, Truckee River Final Decree is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein. A suitable measuring device must be installed and accurate measurements of water placed to beneficial use must be kept.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.



The following describes the multiple points of diversion for Sierra Pacific Power Company Water Treatment Plants, which are shown on the map accompanying Application No. 58882 on file with the State of Nevada, Division of Water Resources, more particularly described as follows:

STEAMBOAT CANAL (HUNTER CREEK RESERVOIR):

The existing point of diversion is situate within the Northeast one-quarter of the Southwest one-quarter (NE1/4 SW1/4) of Section 31, T19N, R18E, MDB&M, Washoe County, Nevada, from said point of diversion, the Southeast corner of said Section 31 bears South 62°04' East, a distance of 3,195.00 feet.

HIGHLAND DITCH (HIGHLAND RESERVOIR):

The existing point of diversion is situate within the Southwest one-quarter of the Southeast one-quarter (SW1/4 SE1/4) of Section 9, T19N, R18E, MDB&M, Washoe County, Nevada, from said point of diversion, the Southeast corner of said Section 9 bears South 75°16' East, a distance of 1,650.00 feet.

IDLEWILD TREATMENT PLANT:

The existing point of diversion is situate within the Southeast one-quarter of the Southeast one-quarter (SE1/4 SE1/4) of Section 10, T19N, R19E, MDB&M, Washoe County, Nevada from said point of diversion, the Southeast corner of said Section 10 bears South 69°57'58" East, a distance of 842.34 feet.

NORTH TRUCKEE DITCH (GLENDALE TREATMENT PLANT):

The existing point of diversion is situate within the Southwest one-quarter of the Northeast one-quarter (SW1/4 NE1/4) of Section 7, T19N, R20E, MDB&M, Washoe County, Nevada, from said point of diversion, the Northeast corner of said Section 7 bears North 39°28' East, a distance of 3,015.00 feet.

ORR DITCH PUMP STATION (CHALK BLUFF TREATMENT PLANT):

The point of diversion is situate within the Northeast one-quarter of the Southeast one-quarter (NE1/4 SE1/4) of Section 17, T19N, R19E, MDB&M, Washoe County, Nevada, from said point of diversion the Northeast corner of said Section 17 bears North 15°39'36" East, a distance of 3,264.77 feet.

ORR DITCH (CHALK BLUFF TREATMENT PLANT):

The point of diversion is situate within the Northeast one-quarter of the Southwest one-quarter (NE1/4 SW1/4) of Section 17, T19N, R19E, MDB&M, Washoe County, Nevada, from said point of diversion of the Southwest corner of said Section 17 bears South 44°40' West, a distance of 3,211.00 feet.
